



DJ/Client Agreement Form

IT IS MUTUALLY AGREED BETWEEN THE PARTIES THAT:

1. Infinite Vibe Productions will provide the service of Professional Disc Jockey and/or Live Band Entertainment under the terms and conditions listed below.
2. The Client will accept the service and terms for the function described hereinafter, provided by Infinite Vibe Productions. The services comprising of:

Disc Jockey Services Live Band MC Duties LED Lighting/FX Other

The service(s) will be provided on a continuous basis as outlined in the following terms and conditions with the exception of normal interruptions such as announcements and speeches.

5. The client shall pay the balance of \$ _____ in full, either seven (7) days prior to the date of the function, dated _____, 20(), or on the evening of the function as decided upon by the Client and Infinite Vibe Productions upon booking, in cash or by check made payable to Aaron Manett.

**In the event of a late payment, a fee of \$50.00 will be assessed and added to the payment terms.*

6. Events cancelled within 90 days are to be confirmed in writing. The client will receive a refund of all monies paid over and above the minimum required deposit of \$150.00.

7. The Client agrees to furnish a facility that completely covers Infinite Vibe Production's equipment from direct sunlight and rain. The client is to provide one six foot table and two standard size chairs for the DJ's use. The Client further agrees to provide sufficient electrical power within twenty feet of the location where the Disc Jockey's equipment is set up. The Client will provide at least one six-foot table and two chairs, for DJ's use to the event location and access ramp if necessary.

Infinite Vibe Productions agrees to set-up at least 1 hour before the above stated contracted time. The client agrees to provide meals for one or two DJs in the case that the event exceeds 4 hours in total length.

Infinite Vibe Productions reserves the right to NOT perform without penalty if it is felt that adequate shelter is NOT provided. In the event of an electrical storm, your event will be suspended and the equipment shut down for the safety of your guests. There are no refunds for suspension or cancellation of events due to weather. Infinite Vibe Productions is not responsible for any mechanical failures due to floor structures, electricity, power outages, acts of God, or inadequate power supply, at the chosen location site.

8. The Client agrees to reimburse for Infinite Vibe Productions all stolen or damaged property directly caused by the client and/or guest(s) of the client. Infinite Vibe Productions reserves the right to terminate services and leave the event if guests are rude and/or inappropriate or become dangerously or extremely inebriated.
9. The DJ agrees to dress appropriately for the function, wearing dress shoes, dress pants, dress shirt and/or suit and tie depending on the formality of the function.
10. Infinite Vibe Productions agrees to provide live music requests during the reception. Infinite Vibe Productions will make every effort to play all requests but cannot be held responsible if specific selections are not available or not played due to content of the request or if time is limited in the event.
11. The Client agrees to permit Infinite Vibe Productions to display a banner or sign with company logo and info, for the purpose of advertising and promotion.
12. In the unlikely event that Infinite Vibe Productions is unable to provide the disc jockey service under the terms and conditions listed above due to accidents or sickness, we guarantee a qualified substitute replacement. In the unlikely event that a replacement cannot be found, Infinite Vibe Productions will make a full refund of any deposit paid by the Client, however, the Client agrees that the refund will be to reasonably cover extent of damages he or she is entitled to and no further damages may be sought against Infinite Vibe Productions. A maximum of 50% of the total contract may be reimbursed due to said damages.
